Dear McClellanville Boat Landing Permit Holder:

The 2012 launch decals will be available for purchase as of December 1, 2011. The annual launch permits are valid from January 1, 2012 through December 31, 2012. Decals for 2012 are also valid for December 2011.

Annual Permit Fees:

Resident - \$50*
Non-resident - \$100

*To qualify for the resident rate, please provide a copy of a current tax bill showing ownership of property within town limits.

Additional annual permits:

A second permit may be purchased at half price for a vehicle registered at the same household (proof of registration required). Only one permit will be issued at half price; all others issued will be at the full rate.

One-week permits: \$30

These allow use of the landing for seven consecutive days. One-week permits are available at the town office (843.887.3712) and Bulls Bay Supply (843.887.3251). Bulls Bay Supply is open 7 days/wk call for hours.

One-day permits: \$10

These allow use of the landing for one day (24 consecutive hours). One-day permits are available at the town office (843.887.3712) and Bulls Bay Supply (843.887.3251). Bulls Bay Supply is open 7 days/wk call for hours.

To apply for an annual launch permit by mail, please enclose:

- a copy of a current tax bill if you are applying for the resident rate
- copies of both registrations if you are applying for a second annual permit at half price
- payment in the form of a check or money order (please do not mail cash) payable to The Town of McClellanville
- **a stamped self addressed envelope**
- the completed permit application – the permit application is available on our website at <http://www.townofmcclellanville-sc.net/form.htm>
- Mail to:

The decals will be mailed out with your copy of your application in the stamped, self addressed envelope you provided.

To apply for a launch permit in person, please bring a copy of your current tax bill, if applying for the resident rate. If applying for more than one permit, please provide copies of vehicle registrations.

Vehicles at the boat landing not displaying a 2012 decal after January 1, 2012 will be issued a citation. Tickets for violations, with required state assessments and surcharges, normally are \$79.90 and higher. If you receive a citation you must either forfeit and pay the penalty or notify the town offices that you wish a hearing before the Town Municipal Court within 10 days of the violation. **Town staff cannot modify or forgive a citation after it is issued.**

1. Vehicles without valid sticker will be ticketed. The McClellanville Town Marshall will have jurisdiction on this property.
2. Stickers **must** be placed on the rear window on the driver's side. All stickers **must be permanently attached** to the rear window.
3. Park in designated spaces only.
4. One (1) sticker per vehicle
5. Keep landing area clean.
6. Storage of boats and overnight parking prohibited.
7. A sticker will only be replaced if the old sticker is brought in. Otherwise, a new permit will be issued at full price. (ex. trade/sell car, replace back glass, etc. remove sticker and bring in as many pieces as possible, including the permit number, for replacement.)
8. Must provide vehicle registration when applying for second, half-priced permit.
9. Only one (1) second permit at half price per household.

The Boat Landing will be closed on Saturday, May 5th for the Lowcountry Shrimp Festival

I have read the above rules and understand that my permit will be revoked if rules are not followed.
